1. PURPOSE

The Climate Change Mitigation and Adaptation Policy of SUB IQ Software Solutions Co. Ltd. ("SUB IQ") has been prepared to guide the company's efforts in combating climate change and enhancing climate resilience. - 3.1.2 We work to significantly reduce greenhouse gas emissions by incorporating up-todate developments and technologies in waste management and recycling into our business processes.
- 3.1.3 We analyze the climate-related risks of our operational areas. Using scientific resources and projections such as those from the Coupled Model Intercomparison Project (CMIP) and the European Centre for Medium-Range Weather Forecasts (ECMWF) Reanalysis data, we identify potential risks and take appropriate measures.
- 3.1.4 We aim to enhance infrastructure resilience and build structures that are more resistant to climate-related risks through the development of adaptation and resilience strategies.
- 3.1.5 By conducting foresight studies on the potential negative impacts of climate change on raw materials, health, biodiversity, and ecological balance, and by developing Nature-Based Solutions (NBS), we strive to build a solid foundation for the future.
- 3.1.6 We aim to inform our employees, suppliers, and stakeholders about climate change mitigation and adaptation, and to strengthen our efforts through active stakeholder engagement.
